Marie YMCA requires that individuals provide the requested information on the attached form regarding income and families sizes so that financial assistance can be provided in a fair and consistent manner. The YMCA requires that you reapply when requested to keep information on your application updated. Assistance will be reviewed for eligibility semi-annually.
